For example, when phosphorus enters water system, it lessens oxygen supply necessary for aquatic life, causing the water to be toxic. Non-compliance penalties can add up to hundreds or thousands of dollars that your business did not originally account for.

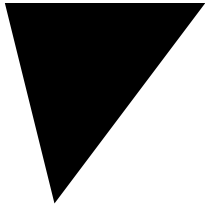

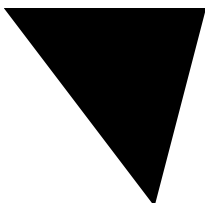
